

Emergency Medical Technician - Basic

Description

If you want an exciting career in a fast-paced environment plus you have an interest in helping people in a health care setting, the Tulsa Tech Emergency Medical Technician (EMT)-Basic program can be your foundation for a rewarding, good-paying job with options for advancement. You will learn the basics of the structure and functions of the human body plus the signs upon which to base decisions about emergency pre-hospital patient care. Additionally, you will be trained in disaster management and ambulance operations through class discussions and practice basic skills in classroom/laboratory settings. While the program is intended to prepare you for work with a basic life support or limited advanced life support ambulance service, you will also be prepared to perform basic emergency care in other settings. Several opportunities await you upon completion of this program including Paramedic training, state and national certifications at the EMT-Basic level, or applying credit toward an associate or bachelors degree in a field currently experiencing an unprecedented demand for trained professionals.

Additional Requirements

Prior to the start of the clinical practicum, students must:

- Undergo a criminal background check including sex offender registration as required by the Oklahoma Child Care Facilities Licensing Act that requires individuals providing care to children under the age of 18 to be free of any criminal history that would indicate a potential for violent abuse against another person.
- Provide verification of immunizations through vaccination records, titer (blood test) results, or declination statements. A list of specific immunizations may be obtained through the Health Sciences Center by calling 918-828-1216.
- Have a current American Heart Association CPR for the Healthcare Provider card.
- Provide transportation to clinical sites.
- Adult students must pay a liability insurance fee for clinicals. This fee is charged for each Tulsa Tech fiscal year (July 1st to June 30th).
- Adult students must pay a drug screening fee for clinicals. The drug screening is required for all students and will be completed sometime before clinicals.

Emergency Medical Technician - Paramedic

Description

Arriving at the scene of an accident or illness, analyzing the signs of physical trauma, and translating the findings to a pre-hospital treatment plan for the patient all fall within the scope of instruction for Tulsa Tech's Emergency Medical Technician (EMT)-Paramedic program. If you are the special person who functions effectively in situations where human life may hang in the balance, you will find this program challenging, rewarding and the gateway to a career as a paramedic or to more advanced study in the health field. Taking the skills learned in EMT-Basic to a higher level, you will learn to manage victims of heart attack, stroke, or an accident, including clearing airways, giving medications through veins or by mouth, and treating wounds or other trauma as well as assisting with childbirth. You will be prepared for critical certifications as well as have the opportunity to take coursework at local hospitals for certifications related to emergency care for children. Whether you use this program for community service, as a career, or as a stepping-stone to other roles in the health profession, you will have a foundation for providing emergency care in any situation.
